# Board/Superintendent:

- ➤ Develop, foster and maintain a classroom environment conducive to effective learning using all available resources
- Establish clear instructional goals and objectives which adhere to the philosophy of the District and communicate these to students and parents

- Assist in the selection of books, materials, resources and equipment that enhance instruction
- Develop, design, and employ multiple teaching and learning instructional strategies to meet the needs of all students for high academic achievement
